The CHCU Continuous High Chair Upper is a continuous metal bar support used to maintain the elevation of rebar in reinforced concrete. They consist of two runner wires and a top supporting wire connected by evenly spaced legs. Continuous High Chair Upper are melted, rolled, and manufactured in the USA.

APPLICATION

The CHCU Continuous High Chair Upper is used to support one layer of steel above another and space them to required distance. It may be used to support steel on soft material form surfaces, such as carton forms or fill material.

INSTALLATION

- Continuous High Chair Upper, when used to support one layer of steel above another, should be placed on the lower layer of rebar so that the runner wires are perpendicular to the lower layer of rebar.
- 2. The upper layer of rebar is then placed perpendicularly on the top, supporting wire.
- Installation on soft material is the same placing on the soft material instead of the lower layer of steel.
