

DESCRIPTION

B29 Loose Plastic Cones are manufactured from acetal thermoplastic material.

APPLICATION

B29 Loose Plastic Cones are used with B1 and B2 Coil Ties.



FEATURES

- B29 Loose Plastic Cones are placed on the coil bolts after the coil bolts have been inserted through the form face but prior to threading the bolt into the coil tie.
- The large end of the cone provides sufficient bearing surface to prevent crushing of the plywood around the bolt hole.
- B29 plastic cones are removed from the concrete with a B15 Cone Removal Wrench and can be reused.
- Cones are to be used for spreader action only and are not designed for scaffold bracket or other accessory loads.
