


# **TECHNICAL DATA SHEET**

## **DESCRIPTION**

A48 Gang Loop Ties are manufactured from high strength steel.

#### **APPLICATION**

A48 Gang Loop Ties are designed for securing and spacing modular type forms.



### **FEATURES**

- Standard units are fabricated with 4-15/16" ends and 1" breakback.
- The longer length allows the tie to be used with gang form bolts and to be broken back before the form has been stripped.
- Other breakbacks, plastic cones and/or water resistant washers are available on special order.
- Safe Working Load is 2,250 lbs. for standard or 3,000 lbs. for heavy ties which provides a factor of safety of approximately 2 to 1.
