DESCRIPTION

A81 Jahn® "A" bracket is fabricated from high strength steel with a cad plated eccentric and painted body

APPLICATION

Can be utilized to hold a single horizontal wale or a single vertical stud with any type of wall form.



FEATURES

- Can be installed before or after the wales have been positioned
- When properly installed, bracket will not loosen from internal vibration of the concrete
- Uses 4-3/4" L&W snap ties
- Easy to install and strip, requires no nailing

INSTALLATION

- Place the bracket on the snap tie end by slipping the tie end into the slots in the bracket body
- 2. Rotate the eccentric loosely over the tie end
- 3. Drop 2x4 waler in place
- Slip the back slot in the bracket body over the tie directly behind the head
- Push the bracket toward the plywood until the tie head emerges through the front of the bracket. Rotate the eccentric over the tie head and tighten
